on button click in GWT? I have a button, when is clicked I want to force the unsubscribing of a handler. I have registered the handler in my constructor, which will be used by other classes as well and this handler has calls to different functions in some other classes. I want to force all classes to use only one single handler for the 'about' event and just unregister that handler on click of any button. Doing `a.unsubscribe(..)` on a handler will remove only that particular handler and will also cause the code to crash since it will try to unsubscribe from the event of a class which it has never been subscribed to. Another solution to this can be to store the handler in a class level variable and prevent the method from being called on the same object, but that would seem a less efficient way since it will be doing some very overhead on each call of that method. So how can this be resolved efficiently? A: Just call the `unsubscribe()` method on the event:

You can't call `unsubscribe()` on the button instance because you can't unsubscribe from a non-deliverable event, but you can use the generic type of the handler to call `unsubscribe()` from the handler instance. Alternatively, if you just want the handler to be removed from any other class instance then consider using the `Key` or `AtomicReference` classes to encapsulate the handler and allow it to be shared.

part. MOTION TO DISMISS Defendant also argues that the court improperly denied its motion to dismiss the complaint. We affirm. Defendant's motion to dismiss the complaint alleged that the complaint was barred by the statute of limitations. See RSA 508:4 (2000). In particular, defendant argued that the complaint was untimely because it was filed more than four years after the date of publication of the original newspaper advertisement and the availability of the defective motorcycle sold to plaintiff. Plaintiff responded that the statute of limitations was equitably tolled during the period that the defendant concealed the defective \*27 motorcycle from plaintiff and failed to correct it. However, plaintiff filed the complaint two months after the statute of limitations had run, and he filed affidavits purporting to show that he did not discover the defects in the motorcycle until after the period of limitations had passed. The trial court denied the motion to dismiss, which was not argued before this court. On appeal, defendant contends that plaintiff failed to present evidence that he had no knowledge of the facts of

the case until after the statute of limitations had run and that the trial court erred by failing to grant the motion to dismiss. "We review the trial court's order denying defendant's motion to dismiss for an abuse of discretion." *McDermott v. Mavitt*, 143 N.H. 364, 367, 727 A.2d 1026 (1999). RSA 508:
